1. Based on the pseudonymous petition received from Sri.S.Satyam along with Andhra Jyothi Paper Clipping of East Godavari against APEPDCL of Rajahmundry Circle for attending of repairs of department materials including Transformers by un-authorized persons and sent out the materials illegally, an enquiry was conducted by the Inspector of Police, Vigilance & APTS PS /Rajahmundry and the enquiry report was forwarded by the Joint Managing Director (V&S), AP.Transco, Vidyuth Soudha, Hyderabad to the CMD EPDCL vide ref.(2).

As per recommendations of the of the Inspector of Police /Vigilance & APTS PS /RJY, the Superintendent of Police & CVO/APEPDCL /Visakhapatnam vide ref.(2) cited, the contractor M/s.Trans Allied Konthamuru committed the following

irregularities during the validity period (upto 31.10.2015) of contractor registration bearing regn.No.01042/CORP.

Carrying out the repairs of Departmental distribution Transformers unauthorizedly at repair shed of M/s.Trans Allieds, Konthamuru in which Ex-Engineer of APEPDCL and his family members are partners.

3. In view of the above discrepancy observed and as per clause No.8 (i) of the revised contractor registration procedure, your firm is liable for suitable action for cancellation of contract registration and blacklisting.
4. Hence, you are therefore directed to show cause as to why the contractor registration (No.01042/CORP) shall not be cancelled and blacklisted for a **period of 3 years within 15 days from the date of receipt** of this notice for indulging the above fraudulent activity.
5. If the reasons on the aforementioned fraudulent activity of your firm are not received within 15 days, contract registration of the firm will be cancelled duly blacklisting for a period of 3 years as per the records available with APEPDCL. Threetimes on note orders of Hon'ble CMD/EPDCL the notices was served to your firm as follows:
 - i. As per instructions, the Show cause Notice was issued to the contractor duly, giving a time period of 15 days time for explanation submission, but the Show cause notice was returned, **due to the address was not traced out and the contractor was not in the said address.**
 - ii. As per instructions, Second time the Show cause Notice was pasted on the D. No: 2-213 of M/S. Trans Allied, Konthamuru in the presence of two officers ADE/SPM and AAE/SPM and obtained two independent witnesses at the premises of M/S. Trans Allied on 12.08.2015, But no reply was received from you to this office.
 - iii. In the mean while a representation was received from you, on dated 04.09.2015 regarding the release of pending bills from the address M/s.Trans Allied, D.No:2-215, Konthamuru, Rajahmundry Rural, hence the Show cause Notice was issued to you to the said address duly, giving a time period of 15 days time for submission of explanation, but the Show cause notice was returned, *due to the address was not traced out and the contractor was not in the said address.*
 - iv. In view of the above, since we have sent the show cause notice thrice (to both old and new addresses) and also pasted the notice on your original address premises. But you're not responded for notice. Hence it is proposed to cancel the contract registration of M/S. Trans Allied and block list for period of 3 years in entire APEPDCL

6. As per clause No.(8) (i) of Terms and conditions of the Contractor Registration procedure,

i. The registering authority reserves the right to cancel or demote or suspend from business or black list without any notice and without assigning any reasons thereof.

7. In view of the said allegation against you, the contractor registration accorded vide registration No.01042/CORP is hereby cancelled and kept the contractor in **black list for 3 years from the date of this notice.**
